3. Types of Personal Data Processed & Purposes

In accordance with the principle of data minimization, this website does not actively request, collect, or store personal or sensitive data. No contact forms, user registration forms, newsletter subscriptions, or comment sections exist on the website. Data handling is restricted to:

- **Guest Artist Data:** We display only the name (or artistic pseudonym) to attribute credit to the galleries, alongside any optional external hyperlinks voluntarily supplied by the artists.
- **Direct Communications (Email):** If you choose to contact the Owner directly via email, your address and any details provided in your message will remain strictly confidential and will only be used to respond to your private inquiry. These details are never saved on a site database, published, or sold to third parties.

- **Navigation Logs:** System servers automatically log standard technical data (such as anonymized IP addresses) exclusively to ensure website stability, monitor performance, and defend against security incidents.

4. Cookies Policy

This website does **NOT** utilize any first-party or third-party profiling cookies, tracking cookies, or intrusive user analytics scripts.

- **Technical Cookies:** We use strictly necessary, essential technical cookies solely to ensure fluid navigation and the correct rendering of the dynamic portfolio image galleries. Under current EU privacy regulations, a cookie consent banner is not required for sites utilizing exclusively essential technical cookies.
- **Local Hosting of Fonts:** All typography styles and web fonts are hosted directly on our local servers rather than fetched from external APIs, successfully preventing any automatic tracking or data transfer to external services (such as Google Fonts servers).
